IV. MONTHLY REPORTS

- **Student Activities**

The Student Activities Report was submitted to the Board and presented by Colton Little, Student Government Vice President. Colton highlighted several recent events.

Student Government and Student Engagement co-sponsored a Holiday Jingle Mingle Party that had 35 attendees, it was a great success bringing together the student body and allowing for students to see friends and make new friends.

Student Engagement has coordinated several impactful service and community initiatives. One example shared was the placement of three CASA for Kids Giving Trees around campus that provided gifts for 11 local children in foster care, generously purchased by employees and students of FVCC. The Board thanked Colton for his report.

- **Faculty Activities**

The Faculty Activities Report was submitted to the Board and presented by Faculty Senate Vice President, Carlin C. Phillips, Assistant Professor, Substance Abuse. The report contained several recent faculty achievements. Carlin highlighted a few examples.

The A&P (Anatomy and Physiology) and Health Sciences Programs hosted “Student-for-a-Day” field trips that were attended by 85 students from Columbia Falls High School, Glacier High School, Flathead High School and Lincoln County High School.

The Music Program hosted several afternoon recitals and an Opera Theatre Workshop Concert. Jordan Neiman toured with the Regal Ensemble and made his Montana Public Radio debut.

Dr. Jacoba Rock, Adjunct Faculty, Social Sciences had a chapter titled “Innovative Grading and Critical Feedback Processes” published in a new educator book.

The Board thanked Carlin for the report.

- **Executive Staff**

V. **COLLEGE ISSUES**

- **Student Success: FVCC and Artificial Intelligence**

Dr. Bryan Brophy-Baerman, Vice President, Academic Affairs gave a presentation on the challenges higher education faces in light of the rapidly changing AI environment. He explained that as AI changes society will change. This will lead to job and education changes and the role that higher education plays. FVCC is approaching this by putting guardrails in place, such as the current Campus Guidelines included on every syllabus and will continue to stay engaged.

- **Academic Program Proposal***

The Curriculum Committee voted to approve the Building Trades, CTS as a new program on December 5th and provided the program description in the Board Packet.

Trustee Peter Akey asked if the CTS program works with local contractors. President Karas responded that the program does work with local contractors, and they are on the Advisory Committee.

Trustee Peter Akey moved that the Board of Trustees approve the Academic Program proposal recommendation as submitted. Trustee Kelly Stimpson seconded the motion. The motion passed unanimously.
