V. COLLEGE ISSUES

- Resolution 26-2, Trustee Resolution Calling for an Election by Mail Ballot

BACKGROUND:

The Board is being presented with Resolution 26-2: Trustee Resolution Calling for an Election by Mail Ballot. The Board of Trustees is required to approve a resolution calling for Trustee Election to be held in conjunction with the regular school elections on Tuesday, May 5, 2026.

In the Flathead/Glacier High School District there is one (1) three-year term beginning in May 2026 and expiring in May 2029.

In the Bigfork/Columbia Falls/Whitefish School District there are two (2) three-year terms beginning May 2026 and expiring May 2029 and one (1) one-year term beginning May 2026 and expiring in May 2027.

FVCC TRUSTEE RESOLUTION CALLING FOR AN ELECTION BY MAIL BALLOT
TRUSTEE ELECTION, MAY 5, 2026

IN ACCORDANCE with Section 20-20-201, Montana Code Annotated, it is hereby resolved,

THAT, the Board of Trustees for Flathead Valley Community College, School District No. 7, of Flathead County, State of Montana, will hold the Annual Regular School Election by mail ballot on Tuesday, the 5th day of May 2026, which date is not less than seventy (70) days after the passage of this resolution.

Voting will end at 8:00 pm on Election Day. The designated place of deposit will be located at

Flathead County Elections Office-Flathead County-Kalispell, MT

THAT, positions for membership in the Flathead Valley Community College District to be voted on are as follows:

in the Flathead/Glacier High School District:
one (1) three-year term expiring in 2029

in the Bigfork/Columbia Falls/Whitefish School District:
two (2) three-year terms expiring in 2029
one (1) one-year term expiring in 2027

If it is later determined that any portion of the election is not required, the Board of Trustees authorizes the cancellation of that portion of the election in accordance with 13-1-304 and 20-3-313, MCA.

BE IT FURTHER RESOLVED that the county election administrator is hereby directed to notify election judges of their appointment and the clerk of the school district to notify the county election administrator of the date of holding said election and request him/her to close registration and to prepare and furnish election materials as required by law. If any of the judges should not be able to serve, the election administrator will choose a replacement from certified judges.

and THAT, Flathead Valley Community College will pay their portion of the School Election and perform such other acts as are specified in the School Laws of Montana that are necessary in the conduct of this election.

No further proceedings were conducted relating to the election.
